The Roland Park Baseball Leagues, Inc (RPBL) is given the opportunity to play baseball thanks to the generosity of several local schools that extend the offer for us to use their facilities. The schools have made the following requests of RPBL teams and spectators.

GILMAN SCHOOL

1. We are the guests of Gilman School. Please be mindful of this fact. ***Gilman School activities always take precedence over RPBL events.***
2. Gilman is aware that our teams gather at 5:30 PM for a 6:00 PM start. If a Gilman game or practice should run late (e.g. extra innings) we must yield to their event and wait patiently until they are finished. This may happen on rare occasions. It is very important that we handle these situations with tact and patience.
3. Our game or practice may begin once Gilman is completely finished with the field and has vacated the benches.
 - a. Please refrain from bringing your equipment to your bench while Gilman is on the field.
 - b. During the spring, it is likely that Gilman will host varsity lacrosse games that will tax their parking capacity. (Fridays are the day when this will most likely occur). Gilman asks that we avoid entering the campus if there is a parking “crunch”. Please park across the street at Bryn Mawr and enter the Gilman campus via the Northern Parkway Bridge.
4. Gilman School requests that the RPBL players, parents, and friends stay away from the 90 foot Varsity baseball diamond. The use of this field is for Gilman Baseball leagues affiliated with Gilman Baseball.
5. Please confine all play to the fields that the RPBL has permission to use.
6. Please discard all trash before leaving.
7. At the conclusion of the games on the American and National League Fields, **the HOME team coach** is expected to rake the batters boxes and pitcher’s mound to fill in the ruts from our games.
8. While on the Gilman campus, please park in a designated parking space. If the parking lot is full, please park at Bryn Mawr and use the Northern Parkway Bridge to enter the Gilman campus.
9. **Do not park** in the “turnabout” beneath the staircase, which leads to the gymnasium.
10. Please respect Gilman’s request that we do not park at the “Fire Lanes”. They are marked with pylons and a yellow curb.
11. Cars may not be driven onto the playing fields.
12. Do not climb on the wooden embankment adjacent to the American & National League Fields.
13. Alcoholic beverages and **smoking** are prohibited on the Gilman Campus.
14. Port-o-pots are located on the Gilman campus for our convenience.

ST. MARY’S SEMINARY & UNIVERSITY

1. Please do not park on the Seminary’s grounds. All cars should park on Roland Avenue. Please respect the parking regulations. Baltimore City Parking enforcement personnel have ticketed cars.
2. Please remove all trash and personal belongings before leaving the field.
3. Alcoholic beverages and smoking are prohibited on the grounds of the Seminary.
4. As the guest of St. Mary’s Seminary, we may begin our game or practice after the Roland Park Country School Softball team has concluded their use of the field for the day.
